Urgent: Your Feedback Needed!

Two documents are attached to this email for your review and comment by tomorrow, **Wednesday**, **January 10th**. We would like to make you aware of proposed changes that can have a significant impact on our current work and future opportunities as Psychiatrists in the state.

One important observation I would like to point out first is that both of the proposed changes below are items that we highlighted and advocated for with our written and verbal testimonies

and individual meetings with the public health and insurance committee chairs in 2022 regarding HB 5001: An Act Concerning Children's Mental Health.

There is a period of public comment that ends tomorrow, on Wednesday Jan 10th, to the dept. of social services about the proposed changes (see attached) to go into effect retrospectively as of Jan 1st. I have attached the entire proposal here (pdf) and highlighted the changes pertaining to the Hospitals and FQHCs (word doc), specifically regarding payment which provides incentive for collaboration between us and medical - specific to those on Medicaid.

See the attached documents or for those short on time- here is my feedback I would share with them without any additional input. Please respond back with your additional feedback or objections to initial comments below:

Collaborative Care model (CoCM)

- Payment to CT FQHCs for CoCM is an important step to support Behavioral Health
 Integration into medical. They serve a large population of CT residents- focused on the
 underserved but open to all. The pediatricians and PCPs are in need of collaboration from
 expert psychiatrists like those within our membership.
 - We would ask that you clarify further what the code G0512 for 60 minutes per month covers. From the wording of the proposal it seems the expectation is that all levels of collaboration and care coordination happen within this time frame. Including psychiatric consultation.
 - Realistically to incentivize collaboration a minimum of 3 hours a month would be ideally covered so that there is adequate time for care coordination by care coordinator, payment for consultation from psychiatry experts and account for the time required for implementation of the Psychiatrists recommendations by PCP for those patients who need it.
 - Any psychiatrist could be impacted by this change if they are interested in lending their expertise to the CoCM model. This is a common sense approach that focuses on safer and higher quality care rather with our existing workforce for safe prescribing.

Child and Adolescent Psych Inpatient bed Funding

• The inpatient child psych bed funding increase pertains to those who are practicing inpatient child psych.

Increased funding we can always support. My question is does the amount go far enough – Please chime in here.

I would like the comments from CPS to reflect our diverse membership as you practice in various settings. This is why we are seeking out your feedback about the proposal to incorporate into a unified CPS response. We are also asking members who are in leadership in other physician organizations to share and ask them to respond. Finally we have also shared this with NAMI as they share this access mission with up so collaboration with the community continues to be in full gear!
